EXPRESSIONS OF INTEREST FOR HEALTH AND SOCIAL CARE INTEGRATION 'PIONEERS'

1. Introduction

The Hull and East Riding Strategic Partnership Board (formally known as the Securing Sustainable Services Programme Board) have an opportunity to express an interest to become a Health and Social care integration pioneer.

The National Collaborative for Integrated Care and Support involves a number of national partners and are referred to as the National Partnership in this context. Participating organisations will be supported to drive forward change which will put their area at the forefront of innovation and reform which in turn will help develop and inform national policy. The following paper describes the how and why the local health and social care community should consider submitting an expression of Interest to be 'Pioneers'.

2. Background

The national partnership is inviting expressions of interest from local areas to become integration 'pioneers' as a means of driving forward change at scale and pace, from which the rest of the country can benefit. The partnership is looking for pioneers that will work across the whole of their local health, public health and social care systems and alongside other departments and voluntary organisations as necessary, to achieve and demonstrate the scale of change that is required. This programme is designed to support CCGs and local authorities to develop their existing and future plans so that they are at the forefront of national reforms and become an area of best practice and innovation for integrated care.

An ambitious vision of making person-centred coordinated care and support the norm across the health and social care system in England over the coming years is set out in *Integrated Care and Support: Our Shared Commitment (2013)* this directive signals how a national partnership will work together to enable and encourage local innovation, address barriers, and disseminate and promote learning in support of better integration for the benefit of patients, people who use services, and local communities. All localities will have to develop these plans but the partnership is inviting expressions of interest from areas that wish to become 'pioneers'.

A local area could comprise of that covered by a particular CCG or local authority, or a larger footprint in which different authorities and health bodies' work together to enable integrated services, the scale of change that is aspired to is key to meeting the criteria to become a pioneer.

3. Information

Selection Criteria

Local communities applying to become pioneers must:

 Articulate a clear vision of innovative approaches to integrated care and support Page 4 of 5

- Demonstrate a plan for whole system integration
- Demonstrate commitment to integrate care and support across a breadth of relevant stakeholders within a local area
- Demonstrate capability and expertise to deliver successfully a public sector transformation project at scale and pace
- Commit to sharing lessons learnt
- Demonstrate robust evidence based vision and approach

Benefits

The benefits for the CCG:

- Alignment with NHS Hull CCG Commissioning strategy
- additional bespoke expertise, support and constructive challenge through a range of national and international experts to help such pioneers realise their aspirations on integrated care
- freedoms and flexibilities in the system to encourage innovation
- Local freedom over chosen models, addressing local barriers that may emerge
- Five years national support

Commitment

Participating organisations would be expected to contribute to accelerated learning across the system.

Process

To become a pioneer expressions of interest to be submitted addressing the required criteria on no more than 10 pages by 28 June 2013.

In mid-July, a Selection Panel made up of representatives from the national partners, three UK and three international experts will consider the Expressions of Interest and any additional information.

Successful partner organisations will be announced in September 2013

4. Recommendations

That the CCG Board consider the content of the report and support the application to progress an expression of interest to become a Health and Social Care Integration Pioneer site.
