

Proposed Changes to Practice Boundary

The purpose of this paper is to provide information to the Primary Care Commissioning Committee on an application received from St Andrew's Group Practice (B81027) to change its practice boundary and to seek the Committee's approval to authorise this.

In considering the application NHS England has followed the guidance from the Policy Booklet for Primary Medical Services (Chapter 6, section 14 – boundary changes)



Background to the Application

	St Andrews Group Practice (B81027)
Main details of the application	Due to recent mergers, St Andrews Group Practice would like to redefine its practice boundary so it is clear where is and is not included. They would like to accurately define the practice boundary so that for new patients, it will focus on the areas they have traditionally served and that are in close proximity to their surgeries. The revised boundary will exclude areas where it is impracticable, due to distance, to provide a full service They currently service 19 residential homes with 82 residents spread over much of West Hull and its satellite communities. They wish to focus on the 9 homes nearest to our surgeries who account for 60 residents The Newington area is currently benefitting from re-development of residential housing. Occupiers will naturally gravitate towards a local medical service provider.

NHS England has no objections on the above changes to practice boundary.




The Primary Care Commissioning Committee is asked to note the report and make a decision based on the information in the report.


