The purpose of the paper is to brief the CCG Board on the Mortality Collaborative.

2.0 Background

NHS Hull CCG is committed to high quality patient care and improving patient's outcomes. As part of that commitment the Director of Quality & Clinical Governance / Executive Nurse explored the following:

- What are the different organisational and multiagency systems and processes that are in place to review patient deaths.
- To consider what deaths could be reviewed across a wider system
- And to understand how the learning could be shared across pathways and organisations, in order to learn and prevent future avoidable harms.

Subsequently two Mortality Summits took place which scoped the collaborative action plan that is now in place.

3.0 Update

The Mortality Collaborative continues to meet bi monthly. The focus of the meeting is the oversight and delivery of the action plan. The action plan is progressing well.
