RISK REGISTER

1. INTRODUCTION

The purpose of this report is to update the Primary Care Commissioning Committee on the primary care related risks on the risk register.

2. BACKGROUND

Individual risk owners are responsible for updating, reviewing and managing their risks. The risk register is a standing agenda item at team meetings and the Health, Safety and Security Meetings for discussion. It is also considered on a bi-monthly basis at the Integrated Audit and Governance Committee, Quarterly to the Planning and Commissioning Committee and Quality and Performance Committee and biannually to the CCG Board to provide assurance on behalf of the organisation.

Risk owners are notified through datix that their risk is due for review and requested to log on to datix to review and update the risk ensuring that all controls and assurances are still valid or updating these as required. The Risk Team regularly check datix and send reminders to risk owners for any overdue updates.

3. CURRENT RISKS ON THE CCG RISK REGISTER

There are currently 28 risks on the CCG risk register. Of these, 6 relate to primary care and are attached at Appendix 1. Four of the risks have been rated as high risks and two as moderate.

Updates to the risk register are highlighted in red.

The following risk has reduced the risk rating from a high risk 12 to an 8. Full details are set out in the register.

- Risk 901 - Lack of capacity/capability within CCG to deliver Strategic Commissioning Plan for Primary Care.

One further risk has been included on the risk register since the previous report. This is highlighted in blue. Full details are set out in the register but in summary.

- Risk 930 - Practices may not remain part of a grouping and thereby become vulnerable/unsustainable as a result do not support delivery of the CCG Strategic Commissioning Plan for Primary Care and are unable to access General Practice Forward View and other funding streams which require working at scale.

The following risk is too be submitted to the Integrated Audit and Governance Committee to be requested to be **closed**. This is highlighted in grey at the end of the register full details are set out in the register.

- Risk 913 - General practices do not come together at sufficient scale to meet the minimum suggested requirement of 30-50,000 patients as outlined in MCP guidance.

The Primary Care Commissioning Committee are also asked to consider whether there are further risks they would recommend adding to the risk register in light of their committees work. A new risk can be added to datix by the relevant risk owner.
