7.1 Strategic Commissioning Plan for Primary Care: Hull Primary Care "Blueprint"

6. GOVERNANCE

7. STRATEGY

7.1 Strategic Commissioning Plan for Primary Care and Primary Care Update Dr James Moult and Dr Vince Rawcliffe, declared a Financial Interest as GP Partners at their respective Practices / GP Grouping.

The Assistant Primary Care Contracts Manager, NHS England (NHSE) provided an update on primary medical care matters including contract issues within Hull and national updates around primary medical care.

Six bids had been received from Hull practices with regard to the GP Resilience Programme (GPRP) funding for 2018-2019. The areas of support, along with the financial support being requested and whether this was supported / declined was identified within the report.

A review of Dispensing Patients across the Yorkshire and Humber region was to be undertaken. This would affect one Hull practice (Sutton Manor Surgery). Committee Members noted the proposed timescale for the review.

The procurement timeline with regard to the Alternative Provider Medical Services (APMS) Calvert & Newington GP practice contract had been published recently and this was noted by Committee Members.

There was a discussion as to reasons why the provider may have wished to terminate the contract and it was noted that the way in which the national APMS contract was written and the clauses in relation to contract termination were primarily based on a Commissioner terminating a contract however a Provider of an APMS contract was also able to terminate a contract. Discussions had taken place with regard to the future patient list size of the City Health Federation practice grouping practice as groupings were required to have a patient list size of at least 30,000 in

order to participate in other CCG schemes and to be recognised as primary care networks by NHS England.

The CCG was looking to commission at scale Minor Surgery services through the GP groupings. The current contracts, due to end September 2018 had therefore been extended until the end of March 2019 for the preparatory work with regard to this to take place.

There was potential for 3 GP Fellowships within the Humber area and an expression of interest had been submitted to Health Education England (HEE) which had been approved. It had been suggested that work with regard to Children and Young people be undertaken although this needed further consideration. The CCG Chair was also meeting with another newly appointed individual (Fay Treloa, Director of Business Engagement and Enterprise, Faculty of Health Sciences, University of Hull) who wanted to support the CCG with work.

Committee Members noted that notification had been received by NHS England (NHSE) with regard to Lloyds Pharmacy's intention to permanently close their branch within Sainsburys in Hessle from 9 February 2019. Concern was expressed by Committee Members as to how easily a pharmacy was able to close if it was no longer viable.

Resolved

(a) Members of the Primary Care Commissioning Committee noted the updates contained within the report.

7.2 PRIMARY CARE COMMUNICATIONS AND ENGAGEMENT UPDATE

The Associate Director of Communications and Engagement provided an update on the progress of the Primary Care Communications and Engagement Group.

The Hull Health and Wellbeing Overview and Scrutiny Commission had received a primary care update at the meeting held on 15 June 2018 and a further update with regard to Extended Access procurement, APMS procurement for the Calvert and Newington GP practice and Overseas Recruitment programme will be provided at the December 2018 Commission meeting.

Two West Hull Health Hub public information events had been held on 22 and 23 May 2018 to view the plans for the building, flood alleviation scheme and highways proposal. The Vice Chair/Lay Representative reported that he attended the events and this had been a useful exercise, especially in terms of some of the questions raised.

Healthwatch had facilitated a Patient Participation Group (PPG) event on 12 July 2018, which aimed to bring people together who were part of a PPG, who would like to join a PPG and GP Practice Managers. Six PPGs had since been visited and useful meetings had been held with some of the Practice Groupings and a further event was to be held on 8 November 2018.

There was a real appetite and enthusiasm from people and concern raised about the demographic in terms of patients in the room and some of the younger patients had not attended.

Resolved

(a) Members of the Primary Care Commissioning Committee noted the update provided.

8.3 Risk Report

The Head of Primary Care provided a risk report with regard to the primary care related risks on the corporate risk register. It was noted that there were currently 27 risks, of these 5 were related to primary care.

The updates to the risks were highlighted in red. Four of the risks had been rated at high and one as moderate.

Clarification was sought as to whether moderate risk should still be identified on the register and it was suggested and agreed that how risks were dealt with in general going forward needed to be looked at.

8.4 EXTENDED ACCESS TO PRIMARY CARE MEDICAL SERVICES - CONTRACT AWARD UPDATE

The Commissioning Lead, Primary Care provided an update with regard to the open procurement process undertaken in relation to the Extended Access to Primary Care Medical Services service.

Following the Extraordinary Primary Care Commissioning Committee meeting on 27 July 2018, the Committee approved City Health Care Partnership CIC as the preferred provider on behalf of a partnership which will use the trading name Hull Primary Care Collaborative. The CCG was currently working through the Alternative Provider Medical Services (APMS) contract to make sure it was fit for purpose. The contract term was 5 years with an option to extend for a further 2 years and would commence on 1 October 2018.

Resolved

(a) Members of the Primary Care Commissioning Committee noted the contents of the report and in particular, the contract award for the Extended Access to Primary Care Medical Services service to the preferred provider – City Health Care Partnership (CHCP).
