### INDIVIDUAL FUNDING REQUEST (IFR) ANNUAL REPORT 2018/19

#### 1. INTRODUCTION

This report presents to the CCG Board the annual report relating to the Individual Funding Requests that are received by the CCG and managed via the CCG's Individual Funding Request service.

It provides information regarding activity, performance and process of the Individual Funding Request (IFR) Service for the financial year (1<sup>st</sup> April 2018 – 31<sup>st</sup> March 2019). North of England Commissioning Support (NECS) provides the IFR Service on behalf of NHS Hull Clinical Commissioning Group.

#### 2. BACKGROUND

The Individual Funding Request service delivers the CCG's duty to commission specific clinical interventions on an individual basis where either the intervention is not available to the general population of Hull or where an individual's clinical condition suggests that the patient would respond to a specific intervention more positively that the general population.

North of England Commissioning Support (NECS) provides the IFR Service on behalf of NHS Hull Clinical Commissioning Group.

#### 3. **INFORMATION**

Attached, appendix 1, is the Individual Funding Request Service annual report 2018/19.

The IFR Service is provided by NECS on behalf of NHS Hull CCG. This report provides the activity, performance and process of the Service for the financial year (1<sup>st</sup> April 2018 – 31<sup>st</sup> March 2019).

The service managed 12 IFR Panel meetings and there were no Extraordinary Panel meetings between April 2018 and March 2019.

During Q4 2018/19 NHS Hull CCG worked with Partner CCGs across the Humber geographical region to harmonise 21 clinical policies. These policies were reviewed by a range of clinicians across the 4 CCGs and ratified by the CCG's Planning and Commissioning Committee.

In the financial year 2018/19, the service managed a total of 1359 IFR submissions. Of the 1359 IFR submissions, 1202 were new cases. The remaining 157 cases were received into the service at the end of 17/18 and were therefore managed in 18/19. A total of 835 cases were clinically triaged and recommended for CCG ratification. 184 cases were considered by the IFR Panel compared to 155 cases in 2017/18 (see 9.3 for further details). During the reporting period, there were no root cause analysis (RCA) undertaken or Datix Reporting for the service or judicial reviews.
