

# Freedom of Information (FOI) Quarterly Report

NHS Hull Clinical Commissioning Group (CCG)

Quarter Two 2019/20 report covering the period from July to September 2019.

#### INTRODUCTION

This paper provides an update on the current position of requests made to NHS Hull Clinical Commissioning Group (CCG) under the Freedom of Information Act 2000 (FOIA) from 1 July to 30 September 2019 and a comparison against quarter two in 2018/19.

Quarter two 2019/20 has seen an increase of 16.4% in the number of FOIA requests received and processed on the number of requests received and processed in quarter one 2019/20 and the average number of days to process the requests has increased by 1 day. Against the same period in 2018/19 there has been a 12.3% decrease and the average number of days to process the requests increased by 3 days. All requests processed in quarter two were completed within the statutory 20 working day deadline. Year to date against the previous financial year, there has been a 9.0% decrease in the number of requests received and processed and the average number of days taken to process them has increased to 17 days.


#### **Subject Area of Request**

The CCG receives a variety of requests and in some cases requests with multiple questions for a variety of information types. The predominant subject area this quarter, however, has been Primary Care Networks. Please see Appendix One for a full list of the various topics.

#### **Outcome of Requests**

Of the 70 requests processed, 17.1% (12) sought information that was 'not held' by the CCG. Information was disclosed in full for 44.3% (31) of the requests. During quarter two there were no requests that were 'refused in full' because the information was held by the CCG but exempt from disclosure. For the remaining 38.6% (27) of the requests the information was partially disclosed, either because only part of the information was held or because an exemption was applied. Exemptions were applied to 17.1% (12) of all requests processed.

The chart below displays the proportion of requests where information was held and disclosed, held and refused, not held or partially held by the CCG:



The following table illustrates the number of instances information was not disclosed and the reason for refusal. As shown in the table, the most commonly applied exemption was Section 40, which demonstrates the CCG is protecting personal data where appropriate.

#### **Category of Requester**


In accordance with the FOIA, the CCG maintains an 'applicant-blind' approach when providing information in response to requests. Where possible the type of FOI requester is recorded by the FOI team to help identify where the main demand for information originates.

#### Missed Requests - Internal Reviews

There were no missed requests (original request not received) and no internal review requests between 1 July and 30 September 2019.

#### **Customer Feedback**

An electronic survey link for the collection of feedback is issued with every FOI response, however, during quarter two there has only been one return (Hull CCG – Q2 – Attachment 1).

#### Decision Notices - Information Commissioner's Office (ICO) and News

Appendix Two shows the ICO's health related Decision Notices for the quarter and any Decision Notices relating to Adult Social Care for the quarter.

The Information Commissioner has renewed her call for FOIA to be extended to cover private companies providing public services (which is valued at £284 billion a year). At the Society of Editors conference, the Commissioner also expressed 'concern that government records had become more "ephemeral", with decisions made by WhatsApp, making it harder to keep and access records of big decision-making'. She spoke about how the ICO processed approximately 6,500 FOI appeals a year and that although they have capacity to take more, " the laws have not kept up with the technology [and] so much government services are delivered by outsourced companies that are not subject to Freedom of Information". The ICO made a case for reforming access to information law in its report 'Outsourcing Oversight?' which was published in January, in which the Information Commissioner said "urgent action" was required to 'bring private companies providing public services under the scope of FOI'.

## DECISION NOTICES Health Related (45 in total) 1 July – 30 September 2019

#### Public Health England

19 Sep 2019, Health

The complainant has requested information relating to the London Food, Water and Environmental Microbiology Laboratory (LFWE) which is part of Public Health England (PHE). PHE has explained that it holds some, but not all, of the information falling within the scope of the request. PHE has provided some of the information it holds. However, it has withheld some of the requested information under section 31 of the FOIA. The complainant is concerned about PHE's reliance on section 31 of the FOIA to withhold some of the requested information. The Commissioner's decision is that the withheld information does engage the exemption under section 31(1)(c), and that the public interest favours maintaining the exemption. The Commissioner does not require any further steps to be taken as a result of this decision notice.

FOI 31: Complaint not upheld Decision notice FS50786980

#### London Ambulance Service NHS Trust

11 Sep 2019, Health

The complainant requested information relating to the outcome of an exercise carried out by the Contacts Management Team at the Trust with the contractor Interserve (Make Ready Contract). The Commissioner considers that the Trust has breached section 10(1) FOIA in the handling of this request. The Commissioner requires the public authority to provide the complainant with a response to this request in accordance with its obligations under FOIA.

FOI 10: Complaint upheld Decision notice FS50859998

#### **NHS** England

11 Sep 2019, Health

The complainant has requested information relating to staffing at North and East London Commissioning Support Unit (NEL CSU). NHS England refused to comply with the request under section 12 FOIA. The Commissioner's decision is that NHS England was correct to apply section12 FOIA and that it was not therefore obliged to comply with the request. The Commissioner does not however consider that NHS England provided the complainant with appropriate advice and assistance in accordance with its obligations under section 16 FOIA. The Commissioner requires the public authority to provide the complainant with appropriate advice and assistance based upon NHS England's revised position that it would exceed the cost limit to comply with this request in isolation.

#### **NHS** Improvement

9 Sep 2019, Health

The complainant has requested information relating to the 'Single Oversight Framework'. The Commissioner's decision is that, on the balance of probabilities, NHS Improvement (NHSI) does not hold the information requested. The Commissioner does not require NHSI to take any steps.

#### United Lincolnshire Hospitals NHS Trust

5 Sep 2019, Health

The complainant has requested information relating to MRI Scanner Housing. The Commissioner's decision is that United Lincolnshire Hospitals NHS Trust (the Trust) has failed to respond to the complainant's request within 20 working days of receipt and has therefore breached section 10(1) of the FOIA. The Commissioner requires the Trust to provide the complainant with a response to the request in accordance with its obligations under the FOIA.

FOI 10: Complaint upheld

Decision notice FS50867662

#### Pension Protection Fund

30 Aug 2019, Health

The complainant has requested information relating to a category of employers known as Special Category Employers ("SCEs"). The Pension Protection Fund ("the PPF") consider the requested information to be "restricted information" which is prohibited from disclosure under section 197 of the Pensions Act 2004 [1]. The Commissioner's decision is that the PPF has correctly applied section 44(1)(a) of the FOIA on the basis that the requested information is prohibited from disclosure under section 197 of the Pensions Act 2004. The Commissioner does not require the PPF to take any further steps.

FOI 44: Complaint not upheld Decision notice FS50814978

#### Public Health England

28 Aug 2019, Health

The complainant has requested information about the identities of those who contributed to a specific report and about future research projects. Public Health England refused both requests as vexatious. The Commissioner's decision is that PHE should have dealt with both requests under the EIR and that it was not entitled to rely on regulation 12(4)(b) to refuse either request. She also finds that PHE failed to respond to either request within 20 working days and failed to provide the complainant with the opportunity to have an internal review of either response. PHE thus breached regulations 5(2) and 11 of the EIR in the way it responded to both requests. The Commissioner requires PHE to take the following steps to ensure compliance with the legislation: issue a fresh response, under the EIR, to both requests, which does not rely on regulation 12(4)(b). EIR 12(4)(b): Complaint upheld EIR 11: Complaint upheld EIR 5(2): Complaint upheld Decision notice FS50833415

#### **NHS** Improvement

23 Aug 2019, Health

The complainant made a freedom of information request to NHS Improvement (NHSI) for the raw data of the Purchase Price Index and Benchmarking Data (PPIB). NHSI refused the request under the section 43(2) (commercial interests) exemption. During the investigation NHSI also cited section 14 (vexatious requests). The Commissioner's decision is that NHSI has correctly applied the vexatious provision at section 14(1) of the FOIA. She does not require any steps to be taken.

**General Medical Council** 

Complainants against doctors are determined by the Medical Practitioners Tribunal (MPT). The decisions of the MPT can be appealed by the General Medical Council (GMC). The complainant has requested the ethnicity of the doctors about whom the GMC made such appeals. The GMC provided a copy of statistics which had been released following an earlier information request from a different applicant, but refused to provide the updated statistics on the basis that the information was exempt under section 40(2). During the course of the Commissioner's investigation the GMC also applied section 14(1) – vexatious, to the request. It also became apparent during the Commissioner's investigation that the GMC held more detailed statistics on the ethnicity of the doctors involved. The Commissioner's decision is that the GMC were not entitled to rely on section 14 to refuse the request. It was however entitled to rely on section 40(2) to withhold both the updated statistics and the more detailed statistics that it holds. The Commissioner does not require the public authority to take any further action this matter.

#### Swansea Bay University Health Board (formerly Abertawe Bro Morgannwg...

19 Aug 2019, Health

The complainant requested various pieces of information relating to Talybont Surgery. Abertawe Bro Morgannwg University Health Board ('ABMUHB') stated that it did not hold the information requested. The Commissioner's decision is that, on the balance of probabilities, ABMUHB does not hold any recorded information falling within the scope of the requests. The Commissioner does not require any steps to be taken. Information Tribunal appeal EA/2019/0318 Under Appeal.

FOI 1: Complaint not upheld Decision notice FS50816849

#### Aneurin Bevan University Health Board

16 Aug 2019, Health

The complainant has requested various information in respect of halal meat served to patients and staff. Following the intervention of the Commissioner, the Health Board provided a further response to the complainant. The Commissioner's decision is that Aneurin Bevan University Health Board has now complied with its obligations under section 1(1) of the FOIA. However, its failure to provide a full response within the appropriate timescales represents a breach of section 10 of the FOIA. As the Council has now complied with its obligations under section 1(1) of the FOIA, the Commissioner does not require the public authority to any steps.

#### **NHS England**

15 Aug 2019, Health

The complainant has requested reports on the urgent and emergency system from NHS England. At the date of this notice, NHS England has not provided a response to the request. The Commissioner's decision is as follows: NHS England has breached section 10(1) of the FOIA as it has not provided a response to the request within 20 working days. The Commissioner requires NHS England to take the following step to ensure compliance with the legislation: Provide a response to the complainant's request of 28 May 2019 that complies with the FOIA.

15 Aug 2019, Health

The complainant has requested the suppressed figures on outcomes of specific disciplinary investigations. The Barts Health NHS Trust (the Trust) refused to provide the requested information citing the exemption under section 40(2) of the FOIA (third party personal data) as its basis for doing so. The Commissioner's decision is that the Trust has correctly applied section 40(2) of FOIA to the withheld information. The Commissioner does not require the public authority to take any steps as a result of this decision notice. Information Tribunal appeal EA/2019/0338 Under Appeal.

#### Wirral University Teaching Hospital NHS Foundation Trust

15 Aug 2019, Health

The complainant has made a request for information relating to Healthcare Assistants . Despite the intervention of the Commissioner, Wirral University Teaching Hospital NHS Foundation Trust (the Trust) has not provided a response to the request in accordance with the FOIA. The Commissioner's decision is that the Trust has failed to respond to the complainant's request within 20 working days of receipt and has therefore breached section 10(1) of the FOIA. The Commissioner requires the Trust to provide the complainant with a response to the request in accordance with its obligations under the FOIA.

#### United Lincolnshire Hospitals NHS Trust

13 Aug 2019, Health

The complainant has requested information relating to the use of catheter-directed thrombolysis to treat arterial occlusions. The Commissioner's decision is that United Lincolnshire Hospitals NHS Trust (the Trust) has failed to respond to the complainant's request within 20 working days of receipt and has therefore breached section 10(1) of the FOIA. The Commissioner requires the Trust to provide the complainant with a response to the request in accordance with its obligations under the FOIA.

## FOI 10: Complaint upheld Decision notice FS50863659

#### Public Health England

12 Aug 2019, Health

The complainant has requested information about advice given by Public Health England (PHE) regarding the Wiltshire novichok poisonings. PHE answered the questions asked and stated that information would be exempt on the basis of section 24, 40 and 42. On review, it later amended its position to state that in fact no recorded information was held. The Commissioner's decision is that, on the balance of probabilities, PHE does not hold any recorded information relevant to the request. PHE has therefore complied with its obligations under section 1(1) of the FOIA. Information Tribunal appeal EA/2019/0335 Under Appeal.

#### South Western Ambulance Service NHS Foundation Trust

12 Aug 2019, Health

The complainant has requested information on the Wiltshire novichok incidents, including emergency response times and details of time at the scene and time taken to get to the hospital by the ambulances attending. The public authority refused to provide the information on the basis of section 24, 38 and 40 of the FOIA. The Commissioner's decision is that South Western Ambulance Service NHS Foundation Trust has correctly applied the provisions of the section 24 exemption and the public interest favours maintaining the exemption and withholding the requested information. She therefore does not require any steps to be taken. Information Tribunal appeal EA/2019/0330 Under Appeal.

#### The Whittington Health NHS Trust

9 Aug 2019, Health

The complainant has requested information relating to numbers of Down syndrome births. The Whittington Health NHS Trust (the Trust) refused to provide the requested information citing the exemption under section 40(2) of the FOIA (third party personal data) as its basis for doing so. The Commissioner's decision is that the Trust has correctly applied section 40(2) of FOIA to the withheld information. The Commissioner does not require the public authority to take any steps as a result of this decision notice. Information Tribunal appeal EA/2019/0311 Under Appeal.

#### Poole Hospital NHS Foundation Trust

9 Aug 2019, Health

The complainant has requested information relating to numbers of Down syndrome births. The Poole Hospital NHS Foundation Trust (the Trust) refused to provide the requested information citing the exemption under section 40(2) of the FOIA (third party personal data) as its basis for doing so. The Commissioner's decision is that the Trust has correctly applied section 40(2) of FOIA to the withheld information. The Commissioner does not require the public authority to take

any steps as a result of this decision notice. Information Tribunal appeal EA/2019/0310 Under Appeal.

FOI 40: Complaint not upheld Decision notice FS50846461

#### **Sherwood Forest NHS Trust**

9 Aug 2019, Health

The complainant has requested information relating to numbers of Down syndrome births. The Sherwood Forest Hospitals NHS Foundation Trust (the Trust) refused to provide the requested information citing the exemption under section 40(2) of the FOIA (third party personal data) as its basis for doing so. The Commissioner's decision is that the Trust has correctly applied section 40(2) of FOIA to the withheld information. The Trust failed to respond to the complainant's request within 20 working days and so breached section 10(1) of the FOIA. The Commissioner does not require the public authority to take any steps as a result of this decision notice. Information Tribunal appeal EA/2019/0309 Under Appeal.

#### **Garstang Medical Practice**

8 Aug 2019, Health

The complainant has requested particular contracts from Garstang Medical Practice ('the Practice'). Having initially provided a response to the complainant, the Practice is now relying on section 14(1) of the FOIA (vexatious request) to refuse to comply with the request. The Commissioner's decision is as follows: The Practice can rely on section 14(1) of the FOIA to refuse to comply with the request. The Practice breached section 17(5) as it did not issue an appropriate refusal notice within the required timescale. The Commissioner does not require the Practice to take any remedial steps.
