6. INFECTION, PREVENTION AND CONTROL REPORT

The Commissioning Lead – Quality presented the Infection, prevention and control report to note.

Highlighted within the report was.

In the period of April 2019 to September 19 that had been no MRSA BSI cases attributed to Hull CCG. HUTHT had reported two MRSA BSI cases via the national reporting system.

In the period of April 19 to September 19 32 cases of clostridium difficile (Cdiff) were attributed to Hull CCG. This was an increase of four cases based on 2018/19 end of quarter two figure. The CCG are currently three cases over the of quarter two objective. HUTHT have reported 27 apportioned cases of Cdiff.

Two GP audits took place in quarter 2 at 2 separate practices one scoring 96.3% and the other 95.7% which demonstrates compliance at the required level. One of

the practices has an action plan in place, the committee requested any further action plans are embedded within the report.
