### PRIMARY CARE COMMISSIONING COMMITTEE TERMS OF REFERENCE

## 1. INTRODUCTION

The purpose of this report is to provide an update to the Primary Care Commissioning Committee regarding the Committee's terms of reference.

## 2. BACKGROUND

The terms of reference for CCG Committees are required to be reviewed annually by the respective Committee prior to approval by the CCG Board and subsequent approval by NHS England as part of the CCG Constitution approval process.

#### 3. INFORMATION

At the June 2020 meeting the Primary Care Commissioning Committee approved revised terms of reference which reflected the new NHS England organisation and amendments reflecting changes in job roles and titles within the CCG. These amendments were subsequently approved by the CCG Board and submitted to NHS England. Confirmation was received at the beginning of June that these amendments have been approved. The current terms of reference for the Committee are included as Appendix 1.

Guidance received from NHS England in late March stated that as 2021/22 is the final year for CCGs there is an expectation that no further changes to CCG constitutions, including changes to Primary Care Commissioning Committee terms of reference, are expected unless absolutely "business critical".
