PURPOSE OF REPORT:

The purpose of this paper is to request Primary Commissioning Committee consider the request from CHCP to provide payment for the prescribing of repeat contraception for the vulnerable group of patients still accessing the service. This follows the decision the committee made in April 2021 to cease the additional payments as patients were to be redirected to their GP for the repeats.

SEXUAL HEALTH SERVICES – REPEAT CONTRACEPTION

1. BACKGROUND

Hull City Council Public Health Service are responsible for commissioning a range of sexual health services for the population of Hull, including repeat prescriptions. The service was commissioned in 2019, CHCP were awarded the contract. The contract no longer included the payment for repeat prescriptions for contraception. It had been agreed with CCG and CHCP Directors of Finance that the CCG would cover the costs incurred by CHCP for a short period of time. This equated to around £25,000 per quarter by NHS Hull CCG, which ensured that the service did not prematurely end without a viable long term way forward.

A solution was then sought and it was deemed that as the GMS contract for GP Practices includes the prescribing of repeat contraception and the monitoring of the health of the patient who is prescribed such medications that the sexual health service needed to sign post the patient to their GPs.

Since July 2021 the service has been directing patients to their GP for their repeat contraception prescriptions. This has proved to be a success as after a few initial queries from GP practices, we are not aware of any issues with the agreed process.

CHCP have as agreed continued to provide repeats for the vulnerable groups ie MESMAC, PAUSE or School Health. They have advised they are providing these for an average of 35 patients per month and have requested payment of £9,758 per annum.

The CCG and the LA have met with the Service Lead and CHCP Contracts and Finance Leads to monitor the situation in October 2021 and February 2022.

There is also a new service provided by Community Pharmacists which NHS England are piloting in various CCG areas including Hull and North East Lincs. In Hull we have 14 Community Pharmacies signed up and ready to provide Oral contraception, with more to come on board shortly. This has given choice to patients in the area. The CCG are working with the LPC and NHS England to promote this service with GP practices and the public.
