The Medicines Optimisation Pharmacist presented the NICE update for January and February 2022 for noting. The report informed Committee Members of changes or additions to NICE publications, and their implications for CCG Commissioners.

The Committee Members were asked to note the January and February 2022 NICE Guidance summary.

TA758 - Solriamfetol for treating excessive daytime sleepiness caused by narcolepsy - NICE stated the guidance was applicable to Secondary Care – acute. Commissioned Via ICS/CCG – NICE stated this would be cost neutral. Discussed at HUTHTs Drugs & Therapeutics Committee

TA599 - Sodium zirconium cyclosilicate for treating hyperkalaemia - NICE stated the guidance was applicable to Secondary care – acute – Commissioned via CCG. Discussed at HUTHTs Drugs & Therapeutics Committee.

NG211 - Rehabilitation after traumatic injury - NICE states the guidance was applicable to Primary care, Secondary care – acute and Community care – Commissioned via ICS/CCG - NICE stated this would be cost neutral. Implementation to be reviewed via Quality Meetings with all providers.

NG81 - Glaucoma: diagnosis and management – commissioned via ICS/CCG - Implementation to be reviewed via Quality Meetings with all providers.

MTG64 - KardiaMobile for detecting atrial fibrillation - NICE stated the guidance was applicable to Primary care and Secondary care – acute – Commissioned via ICS/CCG - NICE stated to assess costs saving. Implementation to be reviewed via Quality Meetings with all providers and relevant CCG commissioning manager.

MTG65 - Sedaconda ACD-S for sedation with volatile anaesthetics in intensive care - NICE stated the guidance was applicable to Secondary care – acute – Commissioned via ICS/CCG - NICE state to assess costs saving.

TA764 - Fremanezumab for preventing migraine - NICE stated the guidance was applicable to Secondary care -acute – Commissioned via CCG/ICS - NICE stated the would be cost neutral. Discussed at HUTHTs Drugs & Therapeutics Committee. Guideline was being reviewed.

TA768 - Upadacitinib for treating active psoriatic arthritis after inadequate response to DMARDs - NICE stated the guidance was applicable to Secondary care - acute - Commissioned via CCG/ICS - NICE stated the cost would be cost neutral. Discussed at HUTHTs Drugs & Therapeutics Committee and HERPC biologic pathway for psoriatic arthritis to be updated.

TA769 - Palforzia for treating peanut allergy in children and young people - NICE stated the guidance was applicable to Secondary care and Tertiary care – Commissioned via ICS/CCG - NICE stated to assess costs locally. Discussed at HUTHTs Drugs & Therapeutics Committee.

QS20 - Colorectal cancer - NICE stated the guidance was applicable to Secondary care -acute and Tertiary care - Commissioned via NHSE, ICS/CCG - NICE stated this would be cost neutral. Implementation to be reviewed via Quality Meetings with all providers.

NG28 - Type 2 diabetes in adults: management - NICE stated the guidance was applicable to Primary care and Secondary care -acute - Commissioned via CCG/ICS - NICE stated to assess costs locally. Implementation to be reviewed via Quality Meetings with all providers.

DG46 - Early CDT Lung for assessing risk of lung cancer in solid lung nodules - NICE stated this guidance was applicable to Secondary care - acute - Commissioned via CCG/ICS.

# Vulnerable People & LD

Update was given on SMI health checks in Primary Care. At the end of 2021/22 NHS Hull CCG achieved 39.4% against a target of 65%, unfortunately this had slipped back further due to data validation, the final result was 37.3%. Significant resources have been put into an ICB workstream to help delivery within PCNs and to understand what was happening with the data. It was noted that NHS England had returned the data set within 2 days with data validation issues however have not advised what the specific elements were required. For assurance Committee Members were advised that a detail plan was in place with CHCP which was reviewed regularly to ensure the target was reached.

The Quality Nursing Team had agreed to pickup maternity, the handover was awaited.

It was noted that attempts were being made to encourage Practices to report their OPEL status more frequently.

# 7.1 PROCUREMENT UPDATE (STANDING ITEM)

The Deputy Chief Finance Officer (JD) provided a paper to update Committee Members of the position in respect of procurement in NHS Hull CCG.

Formal procurement activity was relatively quiet at present.

An open procurement of Wheelchair services was planned to commence in early summer 2022.

It was acknowledged that every decision for a contract award was taken as a procurement decision. The contracting and financial management requires support from the CCGs as the existing statutory bodies in line with their established corporate governance arrangements.

A further consultation had been published in respect of the proposed NHS Provider Selection Regime. This confirmed that the legislation to support the NHS Provider Selection Regime would be on a different (later) timeframe to the Health and Social Care Bill. The consultation had sought views on a number of technical aspects of the proposed Regime and which had closed on 28 March 2022.
