Translation and Interpretation Service Engagement Update Report

1. Introduction

The purpose of this report is to update the committee on the action taken with regard to the Translation and Interpretation Service Engagement that was reported to the committee in February 2022.

2. Background

NHS Hull CCG engaged with communities to determine views and experiences of translation and interpretation services, outside of the existing service provider's patient experience programme.

NHS Hull CCG received, and were asked to respond to, a report from Healthwatch Hull relating to difficulties experienced by the deaf and hard of hearing community accessing services.

On 1st July 2022 NHS Hull will transition into the Humber and North Yorkshire Integrated Care Board.

3. Update

The findings of the speculative engagement exercise were presented to the Primary Care Commissioning Committee in February 2022; following discussion of the findings it was felt that an action plan should be developed to ensure the recommendations of the report, which involve a number of CCG functions, could be fully realised. It was decided the action plan should return to the Primary Care Commissioning Committee to ensure the plan properly transitions into the new organisations and governance structures on 1st July.

As work began on pulling the meeting together NHS Hull CCG received Healthwatch Kingston Upon Hull's report <u>"Breaking Down the Barriers"</u> this report contained additional insight that complimented the translation and interpretation service work already undertaken.

During the formative conversations about the action plan, and the group that should take it forward, it was felt that the findings and recommendations from both reports should inform the action plan requested. During the initial drafting of the plan, synergies emerged with the existing Primary Care Equalities Workplan.

To maximise the impact of the findings from both reports, it is recommended that the findings of the translation services engagement, and the Healthwatch report Breaking Down the Barriers be consolidated into the established Primary Care Equalities Workplan; which has already seen some successes in improving understanding and experiences of communities living with protected characteristics.

It is also recommended that this revised plan would ultimately reside with the Hull Health and Care Partnership but be actioned through the partnership's primary care advisory group, health inequalities and population health group, and the Citizen engagement group. A meeting to discuss the detail and finalise the action plan is scheduled for 28th June 2022.

4. Recommendations

It is recommended that the committee:

- Endorse the consolidation of the recommendations from the translation engagement, and Healthwatch's report relating the deaf community into the established Primary Care Equalities Action Plan.
